### TERMS AND CONDITIONS

- 1. TERM & PAYMENT.** This is a fixed 6-month hire beginning on the start date and ending on the end date above. Rent is payable weekly in advance. Any extension must be agreed in writing. The deposit may be applied only to lawful sums due, with a written statement.
- 2. DRIVER & LEGAL USE.** Only a driver approved by SAMEEGO and validly licensed and insured for the intended taxi/private-hire use may drive. The hirer must keep their driving licence, badge and permissions valid and follow operator, council and road-traffic requirements.
- 3. VEHICLE CARE.** SAMEEGO arranges routine servicing, MOT, recalls and fair wear-and-tear repairs. The hirer must complete daily safety checks, keep the vehicle reasonably clean and report defects promptly. The hirer is responsible for avoidable damage, misuse, lost keys, punctures, incorrect fuel/charging and unauthorised repairs.
- 4. ACCIDENT, DAMAGE & INSURANCE.** Any accident, theft, damage, warning light or breakdown must be reported immediately and the hirer must cooperate with SAMEEGO and the insurer. The stated policy excess applies where required by the policy. Any insurance premium increase may be charged only where actually imposed and evidenced, and where lawful.
- 5. FINES & CHARGES.** The hirer is responsible for parking or traffic penalties, tolls, congestion/clean-air charges and similar charges arising during the hire. SAMEEGO may give driver details to an insurer or authority where permitted or required by law.
- 6. RESTRICTIONS.** No smoking/vaping, sub-hire, racing, unlawful use, unauthorised driver, overseas use or material alteration without written permission. No ownership or purchase right is created by this agreement.
- 7. ENDING & RETURN.** Either party may give 14 days' written notice to end early. Any separately agreed early-end charge is limited to reasonable lawful loss. SAMEEGO may end immediately for non-payment, uninsured/unlawful use, dangerous driving, fraud, licence suspension or serious breach. Return the vehicle, keys, documents and accessories on time, reasonably clean and at the agreed fuel/charge level; it will be inspected and lawful outstanding sums itemised.
- 8. GENERAL.** This agreement is the complete vehicle-hire agreement unless varied in writing. Statutory rights and insurance terms continue to apply. English law applies and the courts of England and Wales have jurisdiction.
